# Indices of Deprivation 2019: Calder Ward















#### Introduction

The Indices of Deprivation 2019 provide information about deprivation in small neighbourhoods. They include the Index of Multiple Deprivation (IMD) which is the official measure of deprivation for a neighbourhood. This report summarises IoD results for Calder Ward. Results are reported for small areas called Lower Layer Super Output areas. Each LSOA has approximately 1,700 people. The summary includes:

## Key results for this ward

 This ward includes one LSOA which is ranked as within the 30% most deprived nationally for England.

#### According to IoD:

- 10.3% of residents are income deprived compared with 14.9% for Calderdale.
- 11.3% of children aged 0-15 live in income-deprived households compared with 19.6% for Calderdale
- 11.8% of older people aged 60 or above are income deprived compared with 14% for Calderdale.
- 8.7% of working age people are employment deprived compared with 11.8% for Calderdale.


- For IMD 2019 Brighouse ward is ranked nine out of 17 wards in Calderdale where one = most deprived.
- IMD 2019 ranks this ward is within the 30% to 40% most deprived decile nationally.



#### **Background information**

- The IoD are based on seven individual domains called Income, Employment, Education Skills and Training, Health and Disability, Crime, Barriers to Housing and Services, and Living Environment.
- IoD includes two supplementary indices for the Income domain of
  - children in families with income deprivation (IDACI) and
  - people aged 60+ with income deprivation (IDAOPI).
- LSOAs were originally developed by the Office for National Statistics for reporting results of similar population sizes. LSOAs tend to be smaller in urban areas and bigger in rural areas due to differences in population density.
- There are 32,844 LSOAs in England of which 128 are in Calderdale and eight in this ward.
